## WORKING PROGRAM OF COOPERATION BETWEEN THE PEOPLES' FRIENDSHIP UNIVERSITY OF RUSSIA AND

## THE ARISTOTLE UNIVERSITY OF THESSALONIKI for 2015-2017 (years)

In accordance with the Co-operation Agreement between the Peoples' Friendship University of Russia (PFUR) and the Aristotle University of Thessaloniki (AUTH) of Greece, authorized representatives of the Parties, namely: on behalf of the PFUR **Rector Prof. V.M. Filippov**, on behalf of the AUTH **Rector Pericles A. Mitkas**, have agreed upon to approve the Working Program for 3 years, for the purpose of implementing the following activities:

1. Academic exchanges: sending professors from the PFUR to the AUTH and from the AUTH to the PFUR for teaching courses and seminars in geospatial science and agriculture technology for the period from one till two weeks on conditions agreed upon, each Party request to be specified for each academic year within the Working Program performance.

Officials in Charge: from the PFUR - Dr. Petr Dokukin, Vice-dean of Agrarian faculty;

from the AUTH *Dr. Dimitrios Koveos* - Dean of Agriculture Faculty.

2. Develop and approve a dual-degree M.Sc. in "Agronomy" and "Land Use Planning". Dual-degree details will be outlines in a separate agreement.

Officials in Charge: from the PFUR – *Dr. Petr Dokukin*, Vice-dean of Agrarian faculty;

from the AUTH *Dr. Dimitrios Koveos* - Dean of Agriculture Faculty.

3. Working out and implementation of annual programs of student exchanges on the reciprocal basis in geospatial specialties, numbers and for periods to be mutually agreed upon, provided that the above programs will be supplemented by language training and tutorials.

Officials in Charge: from the PFUR – Dr. Petr Dokukin, Vice-dean of Agrarian faculty;

from the AUTH *Dr. Dimitrios Koveos* - Dean of Agriculture Faculty.

4. Scientific research in surveying engineering and geospatial science and technology based on joint target programs for a particular research on terms and conditions of the Russian Federation, Greece and International research programs. Universities intend to work on mutual proposals in response on mentioned above programs.

Officials in Charge: from the PFUR – *Dr. Petr Dokukin*, Vice-dean of Agrarian faculty;

from the AUTH  ${\it Dr. Dimitrios\ Koveos}$  - Dean of Agriculture Faculty.

5. Exchange of text-books, handbooks and teaching aids in the fields of cooperation; rendering assistance to each other in drafting working programs and setting up teaching and research labs. The above activities shall be performed as required by the Working Program.

Officials in Charge: from the PFUR – Dr. Petr Dokukin, Vice-dean of Agrarian faculty;

from the AUTH Dr. Dimitrios Koveos - Dean of Agriculture Faculty.

6. Exchange of hyperlinks at the Universities' Internet resources in text or graphic (banners) form. Responsible officials agree on the shape, size, number, and location of hyperlinks, as well as timing of their placement.

Officials in Charge:

from the PFUR – *Dr. Petr Dokukin*, Vice-dean of Agrarian faculty; from the AUTH *Dr. Dimitrios Koveos* - Dean of Agriculture Faculty.

- 7. Exchanges of administrative staff and officials in charge of cooperation, for the following purposes:
- improvement of the university management and structure; implementation of modern administrative methods in higher education institution management in general and international relations of the universities in particular;
  - enhancing group and individual academic mobility;
- elaboration of joint measures aimed at developing distance learning based on the innovative computer technologies;
- applying for joint grants and projects in the framework of the international educational programs;
- seeking solutions to other crucial issues related to the implementation of the Cooperation Agreements of 2015.
- 8. Exchange visits shall fall under mutually agreed schedules but not less than twice a year, on the reciprocal basis in numbers and for periods to be specified by the Parties.

**Officials in Charge:** from the PFUR – *Dr. Petr Dokukin*, Vice-dean of Agrarian faculty; from the AUTH *Dr. Dimitrios Koveos* - Dean of Agriculture Faculty.

9. The Parties shall commit to do their best to provide funding to ensure the implementation of the Working Program, as agreed upon in Article 3 of the Agreement of 2015.

Should either Party fails to finance any clause of the Working Program, it shall inform the other Party at least 3 months prior to the fixed date of the performance with a view to amend the Program and search for additional funds.

The Working Program is issued in four hard copies, two in the Russian and two in the English language, all copies being equally authentic.
